PATHWAY COOPERATION AGREEMENT

THIS AGREEMENT is made this ______ day of ______ day of ______, 20,21 =

BETWEEN: THE UNIVERSITY OF NEW BRUNSWICK, Canada

(hereinafter "UNB")

AND:

SRI VISHNU EDUCATIONAL SOCIETY, India

(hereinafter "SVES")

PREAMBLE

- A. The parties have agreed to co-operate, recognizing the importance for collaboration in education between the two institutions.
- B. As part of this collaboration, the parties wish to pursue an agreement on building a pathway program which lead alumni students of SVES to UNB to continue in graduate and post graduate studies in Computer Science.
- C. This agreement establishes the rules of internal operation of the pathway program between both Universities, commencing with the Faculty of Computer Science.
- D. The parties wish to execute this Agreement to outline the terms and conditions with respect to the Master of Computer Science by Course Work, hereinafter "MCSC".

THEREFORE, in consideration of the premises and the mutual promises contained in this Agreement, the parties agree as follows:

The SVES Pathway Program

- The parties shall establish and jointly agree to accept SVES students who have graduated with an undergraduate degree from SVES and from any of its five campus locations (BVRIT, BVRIT Hyderabad, SVECW, VIT and BVRC), whereby SVES students may apply to UNB to complete their MCSC degree through the Faculty of Computer Science at UNBF (the "UNBF Faculty").
- 2. The SVES Pathway Program's initial structure shall be as follows:
 - (a) The SVES Pathway Program shall be only offered to students from SVES.

- (b) SVES Pathway students will become UNB graduate students on a part-time basis upon admission.
- (c) All of UNB's rules, policies and admission regulations will apply to participating SVES Pathway students, including, but not limited to, the UNB General Regulations on Conduct and the Student Disciplinary Code.
- 3. SVES agrees to provide information about this Agreement to all interested students.
- 4. SVES agrees to provide an opportunity for representatives from the UNB Faculty of Computer Science to visit appropriate forums at SVES to disseminate information about the UNB MCSC program.
- 5. The SVES Pathway Program shall be offered commencing on January 1, 2022. At that time, accepted students in the SVES Pathway Program shall commence their studies, on a part-time basis, following the course requirements as listed in "Appendix A".
- 6. The parties may, from time to time and by mutual agreement, amend the initial SVES Pathway Program structure to include other UNB programs as appropriate.

Program Administration

- 7. The parties shall each identify an Associate Dean or their designate as a contact within each of the respective faculties to track all incoming and outgoing students.
- 8. The Associate Dean or their designate on each campus shall communicate with each other the SVES Pathway Program requirements, subject to all applicable rules, policies and academic regulations of the parties.
- 9. International SVES Pathway students will be required to enroll in the existing international student health insurance plan(s) operated by UNB.
- 10. International SVES Pathway students are responsible for securing their own independent insurance for their time in Canada not spent at UNB. SVES will advise students who are interested in participating in the SVES Pathway Program of this requirement.
- 11. Students registered in the SVES Pathway Program will be registered as part-time students at UNB.

Cohort

- 12. Initially, no more than fifteen (15) may be admitted annually to the SVES Pathway program annually starting in January 2022.
- 13. The parties may, from time to time, amend the number of students who may be accepted.

Applications, Admissions, and Registration

- 14. Subject to this Agreement, UNB shall determine and establish application criteria and admissions requirements for the SVES Pathway Program.
- 15. Students' admission standards shall reflect a commitment to academic excellence, quality, and students' success.

- 16. SVES Pathway students must meet the academic and language requirements of UNB to be considered for admission to the MCSC program of study. In particular, SVES students:
 - (a) must have completed their SVES undergraduate degree program in Computer Science, or closely related field, achieving a First-class standing or better.
 - (b) must have performed at a B+ or better in five (5) key senior undergraduate computer science courses as identified in Appendix "B" and equivalent 7 grade points at SVES
 - (c) must meet the English Language proficiency requirements according to UNB standards as outlined in Appendix "C" and,
 - (d) must provide three (3) highly rated letters of reference.
- 17. Meeting the language and academic requirements does not necessarily mean a SVES student will be admitted into the SVES Pathway Program and will be subject to the consent and recommendation of the UNBF Faculty with final approval coming from the UNB School of Graduate Studies.
- 18. UNB shall operate, oversee and administer the application, admission and registration process for the SVES Pathway Program.

Conferral of Degrees

- 19. SVES students studying on a part-time basis will be required to take a minimum of one (1) course per term. Doing so will allow SVES students to complete their MCSC degree requirements in approximately three (3) years.
- 20. Students must have successfully completed each course with a minimum grade of "C" and A minimum cumulative grade point average of 3.0 (B) must be maintained for required courses in order to be eligible to graduate with an MCSC degree from UNB.
- 21. Graduates admitted under the SVES Pathway Program agreement shall be issued an MCSC degree from UNB.

Marketing

- 22. The parties shall be jointly responsible for marketing the SVES Pathway Program to prospective students and their families.
- 23. Neither party is entitled to use the other party's name, logo or any other related promotional material in its marketing activities including recruitment of students and marketing, without the prior written consent of the other party.

Fees and Expenses

- 24. The parties shall each bear their own expenses in respect of establishment, operation and administration of the SVES Pathway Program.
- 25. Neither party is obliged to provide financial support for graduate students. If such commitment is made to any student, the terms of the financial support shall be documented in a signed and dated addendum acceptable to both Universities.

- 26. Students taking part in the SVES Pathway Program shall be responsible for payment of tuition to UNB. Students shall also be responsible for the cost of study materials, all applicable student organization fees, and for travel and living expenses, including fees associated with necessary travel documentation and visa application(s). Students participating in the SVES Pathway Program shall also be responsible for any other costs or liabilities that may be incurred in connection with their participation in the SVES Pathway Program.
- 27. The tuition fee for the SVES Pathway Program shall be communicated to SVES by June 15th of each year at the rate for domestic and international students set by UNB for the academic year starting each September 1st and may be amended from time to time by UNB at its discretion.
- 28. Insurance Fees SVES students will be required to carry adequate health insurance. Students are responsible for securing independent insurance during their time in the Host Country that is not at the Institutions (i.e., if they travel before or after their Exchange Period). Students coming to UNB must purchase the UNB Guard Me International Insurance.
- 29. SVES shall inform students of the fees associated with participating in the SVES Pathway Program by directing them to the following UNB link : <u>https://www.unb.ca/financialservices/students/Masters and PhD Tuition and Fees/inde</u> <u>x.html</u>
- 30. UNB tuition fees will be due on the dates posted for each term. These can be located at: https://www.unb.ca/financialservices/students/Fee%20Payment%20Deadlines.html
- 31. UNB reserves the right to charge additional customary fees to students registered in the SVES Pathway Program.

Effective Date

32. This Agreement shall be effective from the date of signing until terminated in accordance with this Agreement.

Term

- 33. This Agreement shall remain in force for a period of five (5) years from the effective date unless one or both of the parties indicates in writing their intention to terminate the Agreement as described below.
- 34. This Agreement may be renewed subject to written consent of both parties. The decision to renew the Agreement must be made no later than six (6) months prior to the termination date.

Termination

- 35. Either party may terminate this Agreement immediately if:
 - (a) the other party is in breach of the Agreement.
 - (b) the party gives written notice to the other party in respect of the other party's breach; and
 - (c) the other party fails to remedy the breach within thirty days after delivery of the written notice.

- 36. If a party is declared insolvent or bankrupt, or if any assignment of its property is made for the benefit of creditors or otherwise, or if its interest herein is levied upon under execution, or seized by virtue of any writ of any court of law, or if a petition is filed in any court to declare such party bankrupt or for a reorganization under a bankruptcy law or any similar statute, or if a trustee in bankruptcy or similar officer or a receiver is appointed for such party, then the other party may immediately terminate this Agreement.
- 37. Either party may terminate this Agreement upon at least one year's prior written notice to the other party. Notification of intention to terminate will normally be given to the other University by April 30th of the year in which either party wishes to terminate.
- 38. Upon receiving written notice of termination, the parties shall cease to advertise the SVES Pathway Program.

Confidentiality

- 39. "Confidential Information" includes:
 - (a) trade secrets, ideas, and know-how;
 - (b) data, specifications, computer software or other programs, devices, methods, techniques, drawings, designs, processes, procedures, and improvements;
 - (c) business plans, strategic plans, marketing strategies, and marketing information;
 - (d) research and development;
 - (e) curricula, course and program information;
 - (f) student information;
 - (g) financial information;
 - (h) personal information;
 - (i) human resources and employee information; and
 - (j) any other information that would reasonably be considered sensitive and confidential.
- 40. Notwithstanding the foregoing, Confidential Information does not include any information that is in the public domain.
- 41. The parties acknowledge that, in the course of this Agreement, they may each gain access to Confidential Information of the other party, the disclosure of which would be detrimental to the other party and cause the other party irreparable harm.
- 42. The parties acknowledge and agree that they have no ownership or interest in the Confidential Information of the other party.
- 43. The parties shall, at all times, maintain Confidential Information in strict confidence.
- 44. A party shall not, at any time, without the other party's express prior written consent, or unless required by law:

- (a) disclose any Confidential Information to any person; except to the extent required in the performance of its obligations under this Agreement;
- (b) use Confidential Information for any purpose other than to fulfil its obligations under this Agreement; or
- (c) reproduce or copy any Confidential Information, except in the ordinary course of fulfilling its obligations under this Agreement.
- 45. Upon a party's request, or upon termination of this Agreement, the parties shall immediately return all Confidential Information, without retaining copies.
- 46. The parties acknowledge and agree that the promises contained in this Agreement survive the termination of this Agreement.
- 47. SVES acknowledges that UNB is subject to and required to comply with the New Brunswick *Right to Information and Protection of Privacy Act* (RTIPPA). SVES further acknowledges that, pursuant to subsection 7(1) and other access to information provisions of RTIPPA, UNB may be required to disclose, subject to various exemptions, some or all information which relate to the relationship between SVES and UNB.

Marketing and Use of Logos and Brands

- 48. Except as otherwise authorized in writing by UNB, SVES shall do business in its own name and shall not trade upon the name or credit of UNB. All brochures, advertisements, website materials, or other solicitations for the program that include reference to UNB, regardless of medium and language, shall be subject to UNB's prior written approval. All information posted on websites and promotional materials must be updated regularly and accurately to reflect the nature and requirements of the articulation program. The Parties agree that upon UNB 's request, any information presented by the other Party in its publications and advertisements, including website information that is inaccurate or not supported by facts, regard less of the language used, shall be immediately retracted and/or withdrawn. This Agreement confers no rights upon SVES to use the logos, marks and likeness of UNB in any advertising except as authorized by UNB in writing.
- 49. Except as otherwise authorized in writing by SVES, UNB shall do business in its own name and shall not trade upon the name or credit of SVES. All brochures, advertisements, website materials, or other solicitations for the program that include reference to the JSBF shall be subject to JSBF's prior written approval. All information posted on websites and promotional materials must be updated regularly and accurately to reflect the nature and requirements of the articulation program. The Parties agree that upon JSBF's request, any information presented by the other Party in its publications and advertisements, including website information that is inaccurate or not supported by facts, regardless of the language used, shall be immediately retracted and/or withdrawn. This Agreement confers no rights upon UNB to use the logos, marks and likeness of SVES in any advertising except as authorized by SVES in writing.

Joint Responsibilities

50. Each party shall indemnify and hold harmless the other party in connection with any liabilities, claims, losses, costs, damages, charges and expenses whatsoever, including reasonable legal fees, in any way caused by or arising from the performance or non-performance of its obligations under this Agreement, any negligent act or omission, or any breach of any representation, warranty or covenant.

51. Neither party to this Agreement is liable to the other party for any negligent or wrongful act, either of commission or omission, of the other or of the student. Nothing in this Agreement is to be construed as either enlarging or diminishing any legal obligation or duty owed by one party to the other or to a third party.

Relationship

52. The parties are entering into this Agreement as independent contractors. Nothing in this Agreement shall render either party to be an agent or partner of, or joint venturer with the other party in any respect. Neither party shall have any authority whatsoever with respect to the property or business of the other party except as expressly provided in this Agreement.

Representations and Warranties

- 53. UNB hereby represents and warrants to SVES that, as at the date of this Agreement:
 - (a) UNB is a body corporate existing in good standing under the laws of its place of incorporation with the power, authority, and capacity to carry out the obligations contemplated by this Agreement; and
 - (b) the execution and delivery of this Agreement and the completion of the obligations contemplated by this Agreement have been duly authorized by all necessary action on the part of UNB.
- 54. SVES hereby represents and warrants to UNB that, as at the date of this Agreement:
 - (a) SVES is a body corporate existing in good standing under the laws of its place of incorporation with the power, authority, and capacity to carry out the obligations contemplated by this Agreement; and
 - (b) the execution and delivery of this Agreement and the completion of the obligations contemplated by this Agreement have been duly authorized by all necessary action on the part of SVES.
- 55. These representations and warranties shall continue in full force and effect for the duration of this Agreement.

Arbitration

(a) Any dispute between the parties arising from the interpretation or application of this Agreement shall be submitted to arbitration at Fredericton, New Brunswick, Canada by notice in writing by either party to the other. The dispute shall be decided by a single arbitrator selected by agreement between the solicitors for each party, and absent agreement, in accordance with the *Arbitration Act*, RSNB 2014, c. 100, which shall apply to all arbitrations in respect of this Agreement. A decision of an arbitrator shall be final and binding on the parties.

Notices

56. Any notice or other documents required or permitted to be given under this Agreement shall be in writing and shall be delivered, mailed by pre-paid registered mail, return receipt requested, delivered by electronic mail, addressed to the party to whom it is to be given at

the address shown below or at such other address or addresses as the party shall have last notified the other party in accordance with the provisions of this paragraph:

- 57. Any such notice or other documents shall:
 - (a) If transmitted by facsimile transmission or email, be deemed to have been given and received at the place of receipt on the next business day in the country of receipt, following the day of sending, provided that the sender has received confirmation, electronically or otherwise, of receipt of same on or before the date transmission is deemed to have been received as above, and
 - (b) If mailed, be deemed to have been given and received at the place of receipt on the date of actual receipt.
 - (c) In the event of postal disruption, such notices or document (s) must either be delivered personally or sent by facsimile transmission or email.

Excusable Delay

- 58. Neither party shall be responsible for the failure or delay in performing any of its obligations due, directly or indirectly, by act of God, act of public enemy, acts of governmental bodies or agencies foreign or domestic (including inability to procure materials because of governmental priority orders or allocations or restrictions upon the use of materials or manpower), port congestion, nuclear incidents, sabotage, riot, fire, floods, typhoons or unusually severe weather, earthquakes, explosions or other catastrophes, pandemics, epidemics or quarantine restrictions, strikes, labour unrest or labour shortages, accident, freight embargoes, delays occasioned by carriers or delays of a supplier of materials, components, facilities, energy, fuel, transportation, governmental authorizations or instructions, material or information required from the one of the parties to the other, or because of any other causes beyond either party's control, in whole or in part.
- 59. Upon the occurrence of any excusable delay, the party experiencing such an occurrence shall promptly notify the other party of the occurrence and estimate the duration of said occurrence. Thereupon, the time within which the party experiencing such occurrence shall have to perform its obligations under this Agreement shall, to the extent necessitated by such occurrence and for the duration of such occurrence, be appropriately delayed.

Conformity with Local Laws

- 60. The rights and obligations of the parties under this Agreement shall be subject to all applicable laws, orders, regulations, directions, restrictions and limitations of the governments having jurisdiction over the parties. In the event, however, that any law, order, regulation, direction, restriction or limitation, expropriation, seizure or interpretation thereof shall in the judgment of either party substantially alter the relationship between the parties under this Agreement, or the advantages derived from such relationship, either party may request the other party to modify this Agreement, and if, within thirty days subsequent to making such request, the parties are unable to agree upon a mutually satisfactory modification, then the adversely affected party may terminate this Agreement on six months' written notice to the other party.
- 61. The parties shall each at its own expense in its own country, take such steps as may be required to satisfy the laws and requirements of the respective countries with respect to declaring, recording or otherwise rendering this Agreement valid.

Disclosure

62. This Agreement may be filed with any governmental agency or official if determined to be required by either party.

Applicable Law

63. This Agreement shall be governed by and construed in accordance with the laws of New Brunswick and the laws of Canada, as applicable. The courts of New Brunswick be the sole and exclusive forum in respect of all disputes in respect of this Agreement, subject always to the arbitration provisions contained in this Agreement.

Currency

64. All references to currency and dollar amount in this Agreement are references to the lawful money of Canada, and all payments pursuant to this Agreement shall be made in Canadian dollars.

Entire Agreement

65. This Agreement constitutes the entire agreement between the parties pertaining to the subject-matter of the Agreement and supersedes all prior agreements, undertakings, negotiations, and discussions, whether oral or written, of the parties and there are no warranties, representations, or other Agreements between the parties in connection with the subject-matter of this Agreement except as specifically set forth or referred to in this Agreement.

Amendment

66. This Agreement may be amended only by an instrument in writing properly executed by UNB and SVES. None of the terms, conditions or provisions of this Agreement shall be held to have been changed, waived, varied, modified, or altered by any act or knowledge of either party, their respective agents, servants, or employees unless done so in writing and executed by both parties.

Severability

67. The invalidity or unenforceability of any provision of this Agreement shall not affect the validity or enforceability of any other provision.

Waiver

68. No waiver on behalf of any part of any breach of the provisions of this Agreement shall be effective or binding on such party unless the same shall be expressed in writing and any waiver so expressed shall not limit or affect such party's rights with respect to any future breach of any of the provisions of this Agreement.

Assignment

69. Neither party may assign their rights and obligations under this Agreement without the prior express written consent of the other party, which consent shall not be unreasonably withheld.

Successors and Assigns

70. This Agreement shall bind and endures to the benefit of the parties and their respective permitted successors and assigns.

 - d. algorithms
 - e. computer architecture
- Only candidates with good academic standing are considered for admission.
- Admission is competitive and the number of spaces in the program is limited.
- Documents are the property of UNB and cannot be returned to applicants or forwarded outside UNB. Documents of applicants who do not attend are kept on file for one year. They are then destroyed.
- Deadline date for Applications must be forwarded to School of Graduate Studies on or before March 1st for a September start or June 30th for a January start.

Based on equality and mutual benefit, after friendly consultations, State University of New York at Binghamton (Binghamton University), located at 4400 Vestal Parkway East, Binghamton, NY, USA and Sri Vishnu Educational Society (SVES), located at Anjani Vishnu Centre, Plot No. 7 & 8, Nagarjuna Hills, Punjagutta, Hyderabad, India, establishes a formal and mutually rewarding collaborative relationship in order to promote the academic collaboration between the Parties.

Article 1 Purpose of Agreement

Both Parties agree that the intention of this partnership is to create a specific foundation to encourage exchange and sharing of academic, scientific and cultural experiences amongst their professors, students and administrative personnel. As part of this collaboration, SVES and Binghamton University will broadly explore the following avenues for cooperation:

- 1. Exchanges of teachers and researchers in teaching and scientific research;
- 2. Student exchanges including undergraduate, postgraduate and doctoral students;
- 3. Scientific research cooperation in fields of common interest and establishment of scientific research cooperation platforms;
- 4. Exchange of journals and academic works;
- 5. Short courses, seminars, workshops;
- 6. Discussions on industry/university collaboration;
- 7. Discussions regarding sharing of information on incubation of start-up companies and Binghamton University's Center for Learning and Teaching;
- 8. Discussions regarding joint degree programs;
- 9. Other programs regarded as appropriate for collaboration by both sides.

Article 2 Implementation of Agreement

In order to implement this Agreement, the administrative departments for international cooperation and exchange of the two universities will be responsible for routine contacts between the two universities. The specific terms of collaboration for each initiative implemented under this Agreement shall be mutually discussed and agreed upon in writing by both partners prior to the initiation of the particular activity or program.

Article 3 Alteration of Agreement

If necessary, the two sides can make modifications and supplementations to the present
