- 1) Grievance cell and women Grievance cell Together form Student redressal Committee.
- 2) Any issues Regarding Sexual harassment, Ragging and physical or psychological abuse should be taken serious.
- 3) In all sensitive issues among students names should not be disclosed.
- 4) No tolerance and culture and tradition of the student and area should be kept in mind while dealing with sensitive issues.
- 5) Ragging issues should be transferred to ANTI RAGGING committee.
- 6) Phone numbers and mail ids of GRIEVANCE CELL and WOMEN GRIEVANCE CELL coordinators should be displayed in notice boards. However If students approaches personally, complaint can be taken in written format.
- 7) As soon as committee receives a complaint, coordinator with the principal sign should write a circular and call for a meeting as soon as possible with committee members.
- 8) Next meeting with members and resolutions against redressal of compliant should be documented in register.
- 9) All issues except Sexual Harassment should be solved within 5 days.
- 10) Coordinator should communicate all resolutions including punishments to all stake holders.
- 11) Parents presence is must while counseling the students involved in the issue and special care should be taken to avoid nuisance.

Time taken to Resolve the Issue.

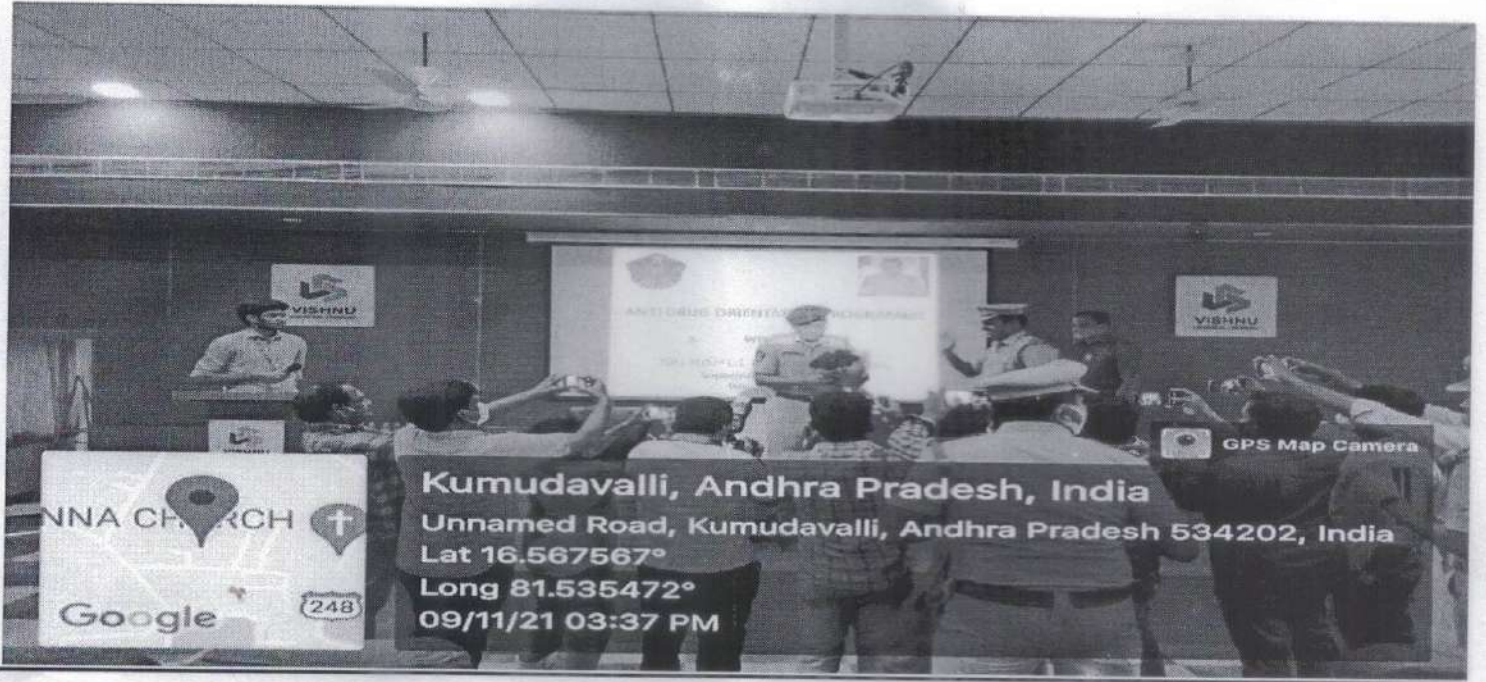
The entire process upto suspension of student took 7 days.
