MEMORANDUM OF UNDERSTANDING

This Memorandum Of Understanding (MOU) is made between **B V RAJU COLLEGE, BHIMAVARAM, A.P., INDIA** (hereinafter **BVRC**) and **BIO ENVIRO CHEMICAL SOLUTIONS PRIVATE LIMITED** (hereinafter **BECS**), **VISAKHAPATNAM, A.P., INDIA**. SCOPE OF MOU

OBJECTIVES

The goal is to foster collaboration, provide opportunity for comprehensive experience and to facilitate advancement of knowledge on the basis of reciprocity, best effort, mutual benefit and frequent interactions. **BVRC** and **BECS** agree:

- I) To exchange information on research and educational programmes
- II) To exchange information on teaching, learning material and other literature relevant to their educational and research programmes
- III) To jointly organize short term continuing educational programmes, on topics of mutual interest and to invite each other's faculty to participate therein
- IV) To jointly organize seminars, conferences or workshops on topics of mutual interest and to invite each other's faculty to participate therein
- V) To exchange students at the graduate level for limited periods of time on a paid internship programmes (for selected students) for the benefit of education on University curriculum basis

BVRC and **BECS** further agree that detailed terms and conditions that guide each activity identified above will be separately determined and agreed upon by the two institutions. These terms shall include a technical description of the proposed activity, financial agreements and persons responsible for its implementation etc.

JOINT SPONSORED RESEARCH, DEVELOPMENT AND CONSULTING

BVRC and **BECS** agree to help identify and invite faculty members from the other institution to participate in conferences, workshops and short- term courses. The terms and conditions for such participation will be worked out by mutual agreement between **BVRC** and **BECS**.

EXCHANGE OF SCIENTIFIC AND TECHNICAL MATERIAL

BVRC and **BECS** will exchange information on research and educational programmes and teaching/learning material and other literature relevant to their educational and research programmes. Further, **BVRC** and **BECS** agree to explore ways to share teaching/learning material and other relevant literature, while respecting each other's Intellectual Property and other Rights.

JOINT CONFERENCES, WORKSHOPS AND SHORT - TERM COURSES

BVRC and **BECS** agree to help identify and invite faculty members from the other institution to participate in conferences, workshops and short - term courses. The terms and conditions for such participation will be worked out by mutual agreement between **BVRC** and **BECS**.

INTELLECTUAL PROPERTY

BVRC and **BECS** agree to respect each other's rights to intellectual property. Further, the intellectual property rights that arise as a result of any collaborative research or activity under this MoU will be worked out on a case-by-case basis and will be consistent with the officially laid down IPR policies of the two institutions.

CO-ORDINATION

Each institute shall appoint one member of its teaching/ research faculty to coordinate the programme on its behalf. Further, a coordination committee, consisting of (a) Head of the institute, **BVRC**, or his/her nominee, (b) Director, **BECS**, or his/ her nominee, (c) Programme coordinator from the side of **BVRC**, and (d) Programme Coordinator from the side of **BECS**, will periodically review and identify ways to strengthen cooperation between the two institutions.

FINANCIAL RESOURCES AND PERSONNEL:

BVRC would pay internship fee per each student as a part of Long Term Internship, which will be decided for every year by both parties.

Any activity carried out within the broad framework of this MOU shall be the subject to the mutual consent of parties, taking into account any constraints of time, funding and other relevant resources.

TENURE AND TERMINATION

This MOU will take effect from the day it is signed by representatives of the two institutions. It will remain valid for 5 years and may be continued thereafter, after suitable review and agreement. Either institution may terminate the MOU by giving written notice to the other institution 6 months in-advance. Once terminated, neither **BVRC** nor **BECS** will be responsible

for any losses, financial or otherwise, which the other institutions may suffer. However, BVRC nor BECS will ensure that all activities in progress are allowed to complete successfully.

AMENDMENTS

Any amendment and / all addenda to the AGREEMENT shall be in writing and signed by the PARTIES hereto and shall only after such execution be deemed to form part of the AGREEMENT and have the effect of modifying the AGREEMENT to the extent required by such amendments or addenda.

ARBITRATION CLAUSE

Should there be a dispute relating to any aspect of academic cooperation, Head of the institute, BVRC and Director, BECS will jointly resolve the dispute in a spirit of independence, mutual respect and shared responsibilities.

1. WHEREAS:

- I. 2. PREAMBLE

To impart industry relevant skills, BVRC has collaborated with various industries and setup Centers of Excellence (CoE) to carry out training and to give a real-time hands-on experience. - 2.3 IBSC & BVRC believes that collaboration and co-operation between themselves will promote more effective use of each of their resources and provide each of them with enhanced opportunities.

3. SCOPE OF MoU

6. BVRC shall provide support for developing a Center of Excellence at University premises.
7. BVRC shall encourage interested faculty engagement in research & consultancy work with AMTZ group of institutions and manufacturers.
8. BVRC shall appoint a 'Point of Contact' for necessary coordination with IBSC.

4.3 JOINT ROLES AND RESPONSIBILITIES OF IBSC AND BVRC

1. The Parties would provide support as mutually agreed upon in project agreements.
2. The Parties would undertake and execute the mutually agreed tasks within a stipulated time frame as detailed in project agreements.
3. The Parties would provide industrial ready workforce.
4. The parties would execute joint research collaboration activities for publishing research articles/patents
5. The Parties will organize the technical Events / Seminars / National Conference / International Conference / Symposia.
6. The parties will develop industrial-oriented courses/programs at the UG/PG level.
7. The Parties may also enter into a separate arrangement/agreement on a case-to-case basis, on such terms and conditions as may be mutually agreed by the parties.

5 DURATION OF MoU

The total time frame of the engagement would be for a period of 3 (three) years from the date of signing this MoU. The term of this MoU may be extended as may be mutually decided by the Parties.

6 DELIVERABLES

The deliverables would be as detailed in the scope of each task, mutually agreed between the parties, from time to time. Requisitions for a specific task could be given by any of the parties on mutually agreed terms of references that would be specific to identified projects.

7 FINANCIAL ARRANGEMENT

This will be undertaken by a separate financial terms & conditions on a project-to-project basis on mutually agreed terms by the parties. Each Party shall bear its expenses in discharge of its responsibilities mentioned in this MoU.

8 CONFIDENTIALITY AND NON-DISCLOSURE

Except as otherwise contemplated by this MoU, each Party (the “receiving party”) undertakes that, in order to protect the proprietary interest of the other Party (the “disclosing party”) in the disclosing Party’s confidential information, it will not, during the term of this

MoU nor at any time thereafter, either use or exploit in any manner, or directly or indirectly divulge or disclose to others any of the disclosing party's confidential information. The receiving party shall treat all confidential information disclosed to it as strictly confidential and only use such confidential information for the purposes of this MoU. Each Party shall ensure that its directors, officers, employees, agents, representatives, students, faculty, Affiliates and attorneys comply at all times with this confidentiality undertaking. This clause does not apply to (i) information is public other than because of a breach of this clause; (ii) disclosure required by law; or (iii) disclosure to a Party's related companies, auditor, banker or advisors. 9. AMENDMENTS TO MoU

11. FORCE MAJEURE

None of the parties shall be held responsible for non-fulfilment of their respective obligations under this MoU due to the exigency of one or more of the force majeure events such as but not limited to acts of God, War, Flood, Earthquake, Strikes, lockouts, Epidemics, Riots, Civil Commotions, etc., provided on the occurrence and cessation of

any such event, the affected party thereby shall give a notice in writing to the other parties within one month of such occurrence or cessation. If the force majeure conditions continue beyond six (6) months, the parties shall jointly decide about the future course of action.

12. ASSIGNMENT OF MoU
